#### Trade Union Issues – Pay and 'Flexible Working'

On pay – Welsh Government has accepted the Pay Review Body recommendation of 3%. CSP has been undertaking an indicative survey of members to gauge reaction and see if there is an appetite for industrial action. More will follow on this – check with your stewards. For Action.

'Flexible working' – section 33 of the NHS Terms and Conditions handbook is being updated from the 13<sup>th</sup> of September 2021. Should give ability for flexibility from day 1 of employment and aims to support a cultural shift – available to all NHS staff. ### Update from the Welsh Allied Health Professions Committee (WAHPC)

Non alerted the Board to a new Welsh Government Diabetes Prevention Programme, a New Chief Social Care Officer and an AHP team to deliver the AHP Strategy for Wales – this includes a fellow for rehabilitation and a fellow for dementia services – look out for details of these people soon! – we will want to influence them!

There's lots of work going on to transform the Primary and Community Services to ensure seamless provision of care for patients in Wales. Funding for this will be provided by the Welsh Government via Regional Partnership Board. There will need to be high level AHP leadership across this sector – find out what's happening locally!
